

SECTION 11 Toxicological information

Information on toxicological effects

	Inhalation of vapours may cause drowsiness and dizziness. This may be accompanied by sleepiness, reduced alertness, loss reflexes, lack of co-ordination, and vertigo. Inhalation of aerosols (mists, fumes), generated by the material during the course of normal handling, may be damaging to the health of the individual.			
Inhaled	 There is some evidence to suggest that the material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Inhalation of toxic gases may cause: Central Nervous System effects including depression, headache, confusion, dizziness, stupor, coma and seizures; respiratory: acute lung swellings, shortness of breath, wheezing, rapid breathing, other symptoms and respiratory arrest; heart: collapse, irregular heartbeats and cardiac arrest; gastrointestinal: irritation, ulcers, nausea and vomiting (may be bloody), and abdominal pain.
