### Potential Health Effects

#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

## SECTION 3 - Composition/Information on Ingredients

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## SECTION 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 0800 764 766 and is available at all times. Have this MSDS with you when you call.

### SECTION 5 - Fire Fighting Measures

<b>Fire and Explosion Hazards:</b>	The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances. Fire decomposition products from this product are likely to be irritating if inhaled.
<b>Extinguishing Media:</b>	Suitable extinguishing media are carbon dioxide, dry chemical, foam, water fog.
<b>Fire Fighting:</b>	If a significant quantity of this product is involved in a fire, call the fire brigade.
<b>Flash point:</b>	>225°C.
<b>Autoignition temperature:</b>	>250°C. This temperature may be significantly lower under particular conditions (slow oxidation on finely divided materials)
<b>Flammability Class:</b>	C2

### SECTION 6 - Accidental Release Measures

<b>Accidental release:</b>	Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include nitrile, neoprene. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Can be slippery on floors, especially when wet. Recycle containers wherever possible after careful cleaning. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

### SECTION 7 – Handling and Storage

<b>Handling:</b>	Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. ### SECTION 10 - Stability and Reactivity
