This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. SECTION 5 - Fire Fighting Measures

SECTION 6 - Accidental Release Measures

Minor spills do not normally need any special cleanup measures. In the Accidental release: event of a major spill, prevent spillage from entering drains or water courses.
