This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

SECTION 5 - Fire Fighting Measures

Fire and Explosion Hazards: The major hazard in fires is usually inhalation of heated and toxic or oxygen

Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. SECTION 6 - Accidental Release Measures

Minor spills do not normally need any special cleanup measures. In the Accidental release: event of a major spill, prevent spillage from entering drains or water courses.

As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include nitrile, neoprene. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product.
