## SECTION 3 - Composition/Information on Ingredients

**Alkalis and additives in aqueous solution. No hazardous ingredients.**

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## SECTION 4 - First Aid Measures

<b>General Information:</b>	You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 0800 764 766 and is available at all times. Have this MSDS with you when you call.
<b>Inhalation:</b>	First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.
<b>Skin Contact:</b>	Gently blot away excess liquid. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.
<b>Eye Contact:</b>	Quickly and gently blot material from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.

## SECTION 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** In a fire or if heated, a pressure increase will occur and the container may burst.

**Extinguishing Media:** In case of fire, use water fog, alcohol resistant foam, dry chemical or carbon dioxide extinguisher or spray.

**Fire Fighting:** Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode..

**Flash point:** >180°C.

**Autoignition temperature:** >250°C. This temperature may be significantly lower under particular conditions (slow oxidation on finely divided materials)

## SECTION 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include nitrile, neoprene. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the NZ Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Can be slippery on floors, especially when wet. Recycle containers wherever possible after careful cleaning. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

**Handling:** Put on appropriate personal protective equipment. Do not breathe vapour or mist. Do not get in eyes, on skin or on clothing. Avoid contact of spilt material and runoff with soil and surface waterways. Use only with adequate ventilation.

**Storage:** Store and use only in equipment/containers designed for use with this product. Keep away from heat and direct sunlight. Keep container tightly

closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabelled containers. Store in accordance with local regulations. Store in a dry, cool and well ventilated area, away from incompatible materials.
