This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

<b>Skin Contact:</b>	Gently blot away excess liquid. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.
<b>Eye Contact:</b>	Quickly and gently blot material from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes. Take special care if exposed person is wearing contact lenses.
<b>Ingestion:</b>	If product is swallowed or gets in mouth, do NOT induce vomiting; wash mouth with water and give some water to drink. If symptoms develop, or if in doubt contact a Poisons Information Centre or a doctor.

## SECTION 5 - Fire Fighting Measures

<b>Fire and Explosion Hazards:</b>	The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances. Fire decomposition products from this product are likely to be irritating if inhaled.
<b>Extinguishing Media:</b>	Suitable extinguishing media are carbon dioxide, dry chemical, foam, water fog.
<b>Fire Fighting:</b>	If a significant quantity of this product is involved in a fire, call the fire brigade.
<b>Flash point:</b>	>150°C.
<b>Autoignition temperature:</b>	>250°C. This temperature may be significantly lower under particular conditions (slow oxidation on finely divided materials)
<b>Flammability Class:</b>	C2

## SECTION 6 - Accidental Release Measures

<b>Accidental release:</b>	Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include nitrile, neoprene. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Can be slippery on floors, especially when wet. <b>Handling:</b>	Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. ## SECTION 10 - Stability and Reactivity

<b>Reactivity:</b>	This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.
<b>Conditions to Avoid:</b>	This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry.
<b>Incompatibilities:</b>	Strong oxidising agents.
<b>Fire Decomposition:</b>	Combustion forms carbon dioxide, and if incomplete, carbon monoxide, various hydrocarbons, aldehydes and smoke. Water is also formed. Small quantities of oxides of nitrogen, sulfur, zinc and phosphorus. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.
